A Poundage Fee of .03¢ per dollar for the first \$1,000 and .01¢ per dollar for each additional \$1,000 or fraction thereof for the handling of money paid into the court on all bail cases.

Effective August 27, 2002 - - on new cases filed with the District Justice on/after August 27, 2002, CVC costs will increase from \$15.00 to \$35.00 on adult cases and from \$15.00 to \$25.00 on juvenile cases. Prisoners must now pay \$60.00 (\$25.00 CC and \$35.00 CVC costs) before being released on parole – per Act 27.\*

\*Effective November 1, 2002, the JCP fee will increase from \$5.00 to \$10.00 for the initiation of any Criminal proceeding in which a conviction is obtained or guilty plea is entered.\*

\*Effective August 8, 2014, the JCP/JCS/ATJ/CJEA will increase to \$35.30.\*

\*\*Effective November 14, 2016 per act 5 of 2016

**Effective November 30, 2017, the JCP/JCS/ATJ/CJEA will increase to \$40.25 per Acts 40 and 44 of 2017\*\***
