Motion by Commissioner McCray to send a letter to the Townships at the Southern End of County regarding the recycling bins in their area. All in favor.


The Commissioners attended a tour at the Fulton County Medical Center.

The Commissioners attended a Ribbon-Cutting Ceremony at the Fulton County Probation Office.


Motion by Commissioner McCray to adjourn the meeting at 1:00 p.m. All in favor.
