Motion by Commissioner Ulsh to sign the MATP report for the period of 4/1/20 – 6/30/20. All in favor.


Motion by Commissioner Shives to sign the Fulton County HSBG report for FY 19/20. All in favor.


The Commissioners talked with Susan Cabbage, Fulton County Food Basket, by conference call regarding the purchase of a storage shed for the Food Basket.


