Motion by Commissioner Bunch to approve budget transfers from the Fulton County Adult, Juvenile, House Arrest to adult Probation in the amount of \$860. All in favor.

Motion by Commissioner Bunch to approve the Verity devices invoice from Hart in the amount of \$1,980. All in favor.


