Motion by Commissioner Wible to approve the Retirement Fund Report for March 2024. All in favor.



Commissioners signed a letter to Carol Wright acknowledging her retirement and thanking her for her service to the county for over nine years.


Motion by Commissioner Hann to adjourn the meeting at 10:33 a.m. All in favor.
