Commissioner Bunch opened up the meeting with prayer and all recited the Pledge of Allegiance to the flag.

Commissioner Bunch announced that there would be an Executive Session at 11:30 a.m. for Legal Matters.

Commissioner Bunch opened up the floor for Public Comments. Stanley Kerlin asked the Commissioners about ongoing litigation matters and the purchase of 101 Lincoln Way East, McConnellsburg, PA. Commissioners read out loud Letters of Appreciation addressed to Commissioner Bunch and Commissioner Wible from the BFJRA, Bedford Fulton Joint Recreation Authority, thanking them for generous donations of labor and equipment for The Old PA Pike Trailhead to create a larger parking area.

Motion by Commissioner Wible to accept the September 10, 2024 Commissioners' Meeting Minutes. All in favor.

Motion by Commissioner Hann to accept the September 10, 2024 Salary Board Minutes. All in favor.

Motion by Commissioner Hann to approve Payroll, dated September 20, 2024, in the amount of \$123,831.96. All in favor.

A CDBG Final Hearing for FFY 2024 funding was held at 9:00 a.m. via Zoom with SEDA COG. No members from the public were in attendance. Separate minutes are on file.

Motion by Commissioner Hann to approve Resolution 3 of 2024, authorizing submission of the application by SEDA COG to the Pennsylvania Department of Community and Economic Development for funding through the Community Development Block Grant (CDBG) Program as authorized under the Housing and Community Development Act [42 USC 5301 and 24 CFR Part 570] and authorizing Commissioner Bunch to execute on behalf of the county. All in favor.

Motion by Commissioner Hann to approve Resolution 4 of 2024, Fair Housing Resolution, to comply with the Fair Housing Act (FHA) which was passed in 1968, a federal law that protects people from discrimination in housing based on race, color, national origin, religion, sex, disability, or familial status and to authorize Commissioner Bunch to execute on behalf of the County. All in favor.

Motion by Commissioner Wible to approve Resolution 5 of 2024, Appointing a Section 504 Compliance Officer and Establishing a Grievance Procedure, naming Chief Clerk Stacey Shives as the officer. All in favor.

Motion by Commissioner Bunch to approve the CDBG Professional & Administrative Services Agreement between the County of Fulton, COSTARS Member Number 2894 and SEDA-Council of Governments (SEDA-COG) for FFY 2023. All in favor.



Motion by Commissioner Bunch to enter into Executive Session at 11:33 a.m. for Legal Matters. All in favor.


Motion by Commissioner Hann to exit Executive Session at 11:55 a.m. All in favor.


