

## FULTON COUNTY BOARD OF COMMISSIONERS' MEETING Tuesday, August 12, 2025 8:30 a.m. at the Commissioners' Office

Commissioner Bunch called the meeting to order followed by prayer. All recited the Pledge of Allegiance to the flag.

Commissioner Bunch announced that there would be an Executive Session for Personnel Matters with a Salary Board meeting to follow.

Commissioner Bunch opened up the floor for Public Comment Period. Fulton County resident Sandra Barton questioned the Commissioners about ongoing litigation matters.

**Motion** by Commissioner Bunch to enter into Executive Session at 8:47 a.m. for Personnel Matters. All in favor.

Motion by Commissioner Wible to exit Executive Session at 9:31 a.m. All in favor.

**Motion** by Commissioner Bunch, after meeting with HR Administrator Mary Huston, to move forward with hiring Kassia College for the position of Office Deputy 1 for the Prothonotary's Office, effective pending clearances. All in favor.

A brief Salary Board meeting was held to determine the wage for new hire Kassia College. Separate minutes are on file.

**Motion** by Commissioner Wible to approve and execute the 2027-2030 TIP (Transportation Improvement Program) Priority List as presented by Justin Evans, Planning & Mapping. All in favor.

**Motion** by Commissioner Hann to approve and execute the 4<sup>th</sup> quarter Certification Statement, for period April 1, 2025 through June 30, 2025, submitted by Services for Children Fiscal Technician Stephanie Mellott. All in favor.

**Motion** by Commissioner Hann to approve and authorize Commissioner Bunch and Chief Clerk Stacey Shives to execute the Certification by Grantee as to Intended Uses of Grant Funds for the Elections Department. All in favor.

**Motion** by Commissioner Bunch to authorize Chief Clerk Stacey Shives to execute the Pennsylvania Liquor Control Board, Local Options Petition Form for the November 4, 2025 General Election. All in favor.

**Motion** by Commissioner Hann to authorize payment to P&W Excavating for paving completed at the entrance way for the McConnellsburg Senior Center located at Woodside Drive in McConnellsburg from the Liquid Fuels \$5 Vehicle Registration Account due to not being covered with CDBG funding, as previously approved, since the project has been completed before release of funding. All in favor.

**Motion** by Commissioner Hann to approve and execute a Letter of Support for Franklin County Commissioner's Office's application for FY 2024 Byrne State Crisis Intervention Program (SCIP) Local Solicitation Funding to be used for a project providing de-escalation and trauma-informed training, coupled with "train-the-trainer" component. All in favor.

Commissioners met with Fulton County Family Partnership Executive Development Director Julie Dovey to discuss the Human Services Block Grant funding. Dovey briefed the Commissioners on the state funding noting that the senate is in recess and that it could possibly be decreased.
