McConnellsburg Volunteer Fire Chief Pete Lynch, Fulton County resident Jim Pittman and EMA/911 Director Brian Barton met with Commissioners to do a Chief 360 Mobile demonstration of Fire & EMS.

Commissioners met with Fiscal Admin Sue Reed and Food Basket Director Sue Cabbage to review a Sub-Agreement. Cabbage explained that state funds now come directly to the County instead of the Food Basket therefore requiring the county to name an administrator of the program through a Sub-Agreement.

Motion by Commissioner Bunch to approve and execute a Sub-Agreement between the County of Fulton and the Fulton County Food Basket, Inc. for Administration of the SFPP, State Food Purchase Program. All in favor.

Motion by Commissioner Bunch to approve and execute a Travel Request Form for Services for Children Director Christine McQuade to attend the "Chief Justice Max Baer's Children's Roundtable Summit" held on April 22-24, 2026 in Hershey, PA. All in favor.

Motion by Commissioner Hann to approve and execute a Tire Quote from Citgo in the amount of \$640.00 for four new tires for the Services for Children vehicle in order to pass inspection. All in favor.




