Commissioner Bunch called the meeting to order followed by prayer. All recited the Pledge of Allegiance to the flag.

Motion by Commissioner Wible to approve the February 17, 2026 Commissioners' Minutes. All in favor.

Motion by Commissioner Hann to approve Account Payables, dated February 24, 2026, in the amount of \$205,405.27. All in favor.

Motion by Commissioner Hann to table a Travel Request Form submitted by Chief Probation Officer Dan Miller until March 3, 2026. All in favor.

Commissioners met with several individuals with MD/IDD/EI for the signing of the Developmental Disabilities Awareness Month Proclamation. Human Services), Lorrie Miller (The Arc of Franklin-Fulton Counties), Lisa Grimes (The Arc of Franklin/Fulton Counties), Wendy Buckwalter (The Arc of Franklin/Fulton Counties), Lana Crouse (The Arc of Franklin/Fulton Counties), Logan Crouse (Consumer of the Arc) and Stacey Brookens (MH/IDD/EI). Also in attendance were Faye and Keith Butts. A group picture was taken with the County Commissioners.

Motion by Commissioner Hann to approve and execute the Developmental Disabilities Awareness Month Proclamation proclaiming "March 2026 as Developmental Disabilities Awareness Month and do commend this observance to all of our citizens and recognize that Fulton County becomes a better place when people with and without disabilities come together to form strong, diverse communities, and knowing we are all **One World, many Abilities!**". Human Services Director Julie Dovey, Franklin/Fulton Family Partnership HRSA Project Director Beth Bryant and Franklin/Fulton Drug & Alcohol Recovery Specialist Joe Bailey met with Commissioners to have a discussion on possible initiatives for opioid reduction.

John Schriever, Sideling Hill Financial, met with Commissioners to provide a review of the Krivak Trust Accounts. Schriever provided a portfolio review of the two accounts noting that the accounts have made \$161,000.00 since he started managing them.

Motion by Commissioner Bunch to approve and execute a Purchase of Service Agreement between the County of Fulton and Pressley Ridge (Child Welfare Services), effective February 11, 2026 through June 30, 2026. All in favor.

Motion by Commissioner Wible to approve and execute an invoice from Elect IT Solutions for IT Staffing and Support Services for March 2026, in the amount of \$10,198.00. All in favor.

Motion by Commissioner Wible to approve and execute a CCAP PComp invoice for the 3rd installment contribution in the amount of \$5,575.00 of the total contribution amount of \$22,300.00. All in favor.

Motion by Commissioner Hann to approve and execute a Letter of Recommendation for MainStreet McConnellsburg supporting and recommending to apply for the T-Mobile Community Grant opportunity "to improve and modernize the downtown street lighting with the goal of enhancing public safety, strengthening the downtown business district and improving the overall community appearance". All in favor.

Motion by Commissioner Wible to approve and execute a "Report of County Fee for Local Use Funds" to be submitted to PennDOT, as presented by Chief Clerk Stacey Shives. All in favor.

Motion by Commissioner Bunch to approve and execute an invoice from Huntingdon County for the remainder of the NTIA Project Contribution in the amount of \$270,000.00 (\$90,000.00 previously paid). All in favor.

Motion by Commissioner Bunch to approve and execute the 2026 Compensation Plan from Services for Children Director Christine McQuade to be submitted to the state for compensation of wages. All in favor.

Commissioners met with Elections Director Linda Doyle for approval for a recycling event and election updates.

Motion by Commissioner Bunch to approve a recycling event flyer "Electronics and Appliances Recycling Days", submitted by Recycling Coordinator Linda Doyle, to be held on March 18th from 12:00 p.m.-5:00 p.m. and March 21st from 9:00 a.m.-1:00 p.m. located at 610 East North Street, McConnellsburg, PA 17233. All in favor.

Motion by Commissioner Hann to adjourn at 11:15 a.m. All in favor.




