



FULTON COUNTY BOARD OF COMMISSIONERS' MEETING
Tuesday, April 7, 2026
8:00 a.m. at the Commissioners' Office

Present: Commissioner Randy H. Bunch, Commissioner Steven L. Wible, Commissioner Hervey P. Hann and Chief Clerk Stacey M. Shives

Commissioner Wible called the meeting to order followed by Commissioner Bunch saying a prayer. All recited the Pledge of Allegiance to the flag.

Motion by Commissioner Wible to approve the March 31, 2026 Commissioners' Minutes. All in favor.

Motion by Commissioner Hann to approve Account Payables, dated March 31, 2026, in the amount of \$38,214.62. All in favor.

Motion by Commissioner Wible to enter into Executive Session at 8:00 a.m. for Personnel Matters pertaining to the Prothonotary's Office. All in favor.

Motion by Commissioner Hann to exit Executive Session at 8:11 a.m. All in favor.

Commissioner Bunch opened up the floor for Public Comment Period. Fulton County Resident Fred Black spoke with Commissioners about a grant opportunity that is about to expire the end of May for the Hustontown Senior Center. Black recommended using the funding for lighting. Commissioners directed Black to coordinate with Building and Maintenance Director Brad Seville on the project.

Commissioners met with HR Administrator Mary Huston to discuss hiring potential candidates for Per Diem Deputy Coroner position and part-time Victim Services Coordinator position.

Motion by Commissioner Wible to hire Darius Deshong for the Per Diem Deputy position, effective immediately. All in favor.

Motion by Commissioner Hann to hire Vonda Shatzer for the part-time Victim Services Coordinator position in the District Attorney's Office, based on continued grant funding for the position at 24 hours per week, effective pending clearances. All in favor.

A brief Salary Board meeting was held to set the salary for the new hires. Separate minutes are on file.

Motion by Commissioner Hann to enter into Executive Session at 9:00 a.m. for Legal Matters with Special Counsel and the County Solicitor. All in favor.

Motion by Commissioner Wible to exit Executive Session at 9:30 a.m. All in favor.

Commissioners met with Sarah Kirchner, Sr. Grant Analyst and Wendy Yeager, Unit Supervisor, both with the Office of the Budget, in regards to reallocating funds from the RACP grant applied for in previous years since criteria wasn't met for the proposed project. Yeager and Kirchner explained that a new round of funding would soon be coming up that the county could apply for with a new project.


Chief Probation Officer Dan Miller met with Commissioners to discuss ideas he was working on for using grant funding as a means of adding additional hours for employees in his department. Miller plans to meet with the Commissioners again on April 28th for final approval.

Motion by Commissioner Wible to adjourn at 11:17 a.m. All in favor.


