SEDA Cog Program Analyst Hanorah Lucas spoke briefly, via Zoom, with Commissioners to have a letter approved for a revision to FFY 2024 CDBG funding.

**Motion** by Commissioner Bunch to approve a Guardian Ad Litem Provider Agreement between the County of Fulton and Janice M. Hawbaker, the associate of Kaminski, Hawbaker & Salawage, P.C., for Guardian Ad Litem duties for Fulton County Services for Children, effective July 1, 2026 through June 30, 2027. All in favor.

**Motion** by Commissioner Hann to approve a Guardian Ad Litem Provider Agreement between the County of Fulton and Abigail Salwage, Esq., the associate of kaminski, Hawbaker & Salawage, P.C., for Guardian Ad Litem duties for Fulton County Services for Children, effective July 1, 2026 through June 30, 2027. All in favor.

**Motion** by Commissioner Bunch to approve and execute the Pension Report for May 2026, as presented by HR Administrator Mary Huston, in the amount of \$71,324.86. All in favor.

**Motion** by Commissioner Hann to approve and execute the "Unofficial Returns Reporting Form", as presented by Elections Director Linda Doyle, to be submitted to the Department of State from the General Primary Election that was held on May 19, 2026. All in favor.

Commissioners met with John Schriever, Sideling Hill Financial, for a review of the Krivak Trust Accounts. Schriever provided a Portfolio Review of the two managed accounts. Commissioners requested that the account ending in 2777 be maintained at \$50,000.00 and to move remaining funds in the amount of \$10,287.91 to the account ending in 2776. Schriever will meet with Commissioners again in August/September for another review.


