



FULTON COUNTY BOARD OF COMMISSIONERS' MEETING
Tuesday, June 16, 2026

Commissioner Bunch called the meeting to order followed by prayer. All recited the Pledge of Allegiance to the flag.

Commissioner Bunch opened up the floor for Public Comment Period. Dublin Township Secretary Heidi Seymore addressed concerns to the Commissioners about the township's sewer plant. Commissioners recommended for the township to set up a meeting with state legislators. Fred Black, Hustontown Senior Center, met with Commissioners to seek approval for the Senior Center to apply for grant funding for building maintenance.

Motion by Commissioner Hann to add "Hustontown Senior Center, Letter of Support" to the June 16, 2026 Agenda. All in favor.

Motion by Commissioner Wible to approve writing a Letter of Support for the Hustontown Senior Center to apply for grant funding for building maintenance. All in favor.

Motion by Commissioner Wible to approve the June 9, 2026 Commissioners' Minutes. All in favor.

Motion by Commissioner Hann to approve Account Payables, dated June 16, 2026 in the amount of \$253,441.31. All in favor.

Building and Maintenance Director Brad Seville met with Commissioners to seek approval for a quote from G.M. Shearer Plumbing and Castle Window Cleaning.

Motion by Commissioner Wible to approve and execute a quote from G.M. Shearer Plumbing, Heating & A/C for the installation of a replacement A/C unit in the amount of \$12,850.00 to include inside and outside unit, line set, repair of outside pad, Honeywell Thermostat, low voltage wiring and labor. All in favor.

Motion by Commissioner Bunch to approve and execute a quote from Castle Window Cleaning for a 5-year contract at \$1,875.00 per year for interior and exterior cleaning for the newly purchased building, 101 Lincoln Way West, McConnellsburg, PA. All in favor.

A virtual meeting was held with the Bedford County Commissioners to discuss the TOPP Trail and updates of the BFJRA, Bedford Fulton Joint Recreational Authority. Also in attendance were the Bedford County Chief Clerk Debra Brown, Bedford County Planning Director Stephanie Clevenstine and Fulton County Mapping/Planning Director Thomas Peppernick. No action was taken.

Motion by Commissioner Hann to authorize the purchase of a new truck and plow for the Building and Maintenance Department due to the current one rusting and needing replaced and to submit to CCAP for reimbursements through the PCOMP and PCoRP Safety Grants. All in favor.

Motion by Commissioner Wible to approve and execute the 2026-2027 PCoRP Loss Prevention Grant Program Application to be submitted to CCAP Risk Management Director Keith Wentz and Underwriting and Risk Control Assistant Julianna Keppley for a requested grant amount of \$25,000.00 to help aid in the purchase of a new truck and plow for the Maintenance Department. All in favor.

Motion by Commissioner Bunch to approve and execute the second progress billing for professional services rendered in connection with audit services for the year ended 2025 from External Auditors MaherDuessel, in the amount of \$15,000.00. All in favor.

Motion by Commissioner Bunch to approve and execute an invoice from CES Engineering, LLC for Professional Surveying and Administrative/Clerical work completed April 27-May 31, 2026 for the Warfordsburg Senior Center CDBG Project, in the amount of \$673.75. All in favor.




