Election Department employee Nya Minnier met with Commissioners to have a "2026 Survey of Polling Place Accessibility for the Elderly and Persons with a Disability County Certification" approved and signed.

Commissioners discussed a proposed Lease from the Needmore Volunteer Fire Company however, there is a current 5-year Lease in place that expires October 1, 2029. Commissioners asked Chief Clerk Shives to send an email to the Fire Company explaining.

A Human Services Block Grant Plan Public Hearing was held at 9:00 a.m. A handout was given explaining the history of the grant and what it is and how the FY 26-27 funding was and will be used. Programs using the grant funding include- Mental Health Community Base Funded Services (MH); Behavioral Health Services Initiative; Intellectual Disabilities Community Base Funded Services (IDD); Act 152 Drug and Alcohol Services (D&A); Homeless Assistance Program Funding and Human Services Development Funds (HSDF). Human Services Executive Development Director Julie Dovey explained that the final application and the plan will be submitted by the due date of August 1, 2026 and will be available on the county's website.

All in favor.

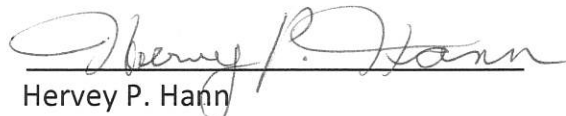
Motion to table Scaringi Law Office invoices until further direction from the County Solicitor.

Motion by Commissioner Bunch to adjourn at 10:15 a.m. All in favor.

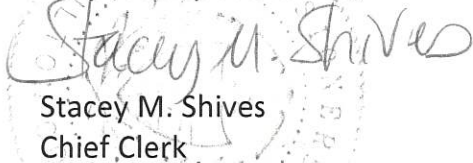
