Commissioner Bunch called the meeting to order followed by prayer. All recited the Pledge of Allegiance to the flag.

Motion by Commissioner Bunch to enter into Executive Session at 8:10 a.m. for Personnel Matters related to county departments in the courts system. All in favor.

Motion by Commissioner Hann to exit Executive Session at 8:41 a.m. All in favor.

Commissioner Bunch opened up the floor for Public Comment Period. Founder & President of "Bridges not Barriers Foundation" and Certified Recovery Specialist/Safety Crisis Management Instructor Collin McCloskey met with Commissioners to introduce his organization and express his desire to work with Fulton County to support individuals and families through recovery support, reentry assistance, mental health advocacy, resource navigation and community partnerships. McCloskey shared that he currently facilitates a free weekly peer support group in McConnellsburg.
