Motion by Commissioner Bunch to approve and execute a Reappointment Letter for Erin Glenn to serve a fourth term on the Franklin/Fulton Mental Health/Intellectual & Developmental Disabilities/Early Intervention Advisory Board, effective July 2026 through July 2029. All in favor.

Motion by Commissioner Wible to authorize Commissioner Hann and Chief Clerk Stacey Shives to complete the SAP&DC 2027-2047 Long Range Transportation Plan Survey. Commissioner Hann abstained, motion carried.

Motion by Commissioner Hann to approve and execute Services for Children Purchase of Service Agreements for Community Specialist Corporation; New Outlook Academy and Summit Academy, Inc., effective July 1, 2026 through June 30, 2027. All in favor.

Motion by Commissioner Bunch to approve and execute three ForensicDx Invoices (#5138-\$3,920.50; #5123- \$3,459.00; and #5119-\$3,709.00) submitted by County Coroner Berley Souders, for a total amount of \$11,088.50. All in favor.

Motion by Commissioner Hann to approve and execute a LocalGov Software Maintenance Agreement between the Fulton County Treasurer & Tax Claim and RBA (Professional Data Systems, Inc.), effective date of signing, July 27, 2026 through July 27, 2027. All in favor.

Motion by Commissioner Wible to retroactively approve and execute the Franklin/Fulton Clerk of Courts Agreement between the County of Franklin, through the Franklin County Commissioners, and the County of Fulton, through the Fulton County Commissioners, for the Prothonotary's Office at a rate of \$325.00 per day, for up to two (2) employees, not to exceed \$10,000.00 for the life of the contract, effective July 27, 2026 through December 31, 2026.
