Motion by Commissioner Wible to adjourn at 11:20 a.m. All in favor.

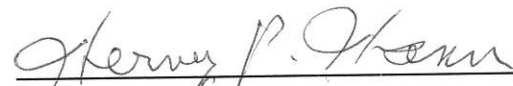

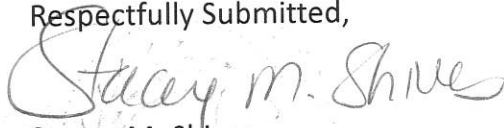
