**Motion** by Commissioner Wible and seconded by Commissioner Hann that all employees not in an office with an elected official as the department head receive the following pay increase for 2024:

\$ .50 cent per hour increase for all non-union employees who were employed by the County as of 8/31/2023.

2.50% increase for Court Crier, Tipstaff and Tax Claim.

1.00% increase for employees hired in September or October 2023. No increase will be given to new hires in November or December 2023.

All in favor.

**Motion** by Commissioner Hann and seconded by Commissioner Wible that employees in the Commissioner's Office receive the following pay increase for 2024:

\$.50 cent per hour increase for all full-time employees who were employed by the County as of 8/31/2023.

1.00% increase for employees hired in September or October 2023. No increase will be given to new hires in November or December 2023.

All in favor.

**Motion** by Commissioner Bunch and seconded by Treasurer Mellott-Keefer that employees in the Treasurer's Office receive the following pay increase for 2024:

\$.50 cent per hour increase for all full-time employees who were employed by the County as of 8/31/2023.

1.00% increase for employees hired in September or October 2023. No increase will be given to new hires in November or December 2023.

All in favor.

**Motion** by Treasurer Mellott-Keefer and seconded by Commissioner Hann that employees in the District Attorney's Office receive the following pay increase for 2024:

\$.50 cent per hour increase for all full-time employees who were employed by the County as of 8/31/2023.

1.00% increase for employees hired in September or October 2023. No increase will be given to new hires in November or December 2023.

District Attorney is to be paid \$1000 less than a Judge in the Court of Common Pleas.

All in favor.

**Motion** by Commissioner Bunch and seconded by Commissioner Hann that employees in the Prothonotary's Office receive the following pay increase for 2024:

\$.50 cent per hour increase for all full-time employees who were employed by the County as of 8/31/2023.

1.00% increase for employees hired in September or October 2023. No increase will be given to new hires in November or December 2023.

All in favor.

**Motion** by Commissioner Hann and seconded by Commissioner Bunch that the employees in the Coroner's Office receive their pay for 2024 in accordance with the October 17, 2023 Salary Board Minutes that became effective January 1, 2024. All in favor.

**Motion** by Commissioner Wible and seconded by Commissioner Hann that employees in the Sheriff's Office receive the following pay increase for 2024:

\$.50 cent per hour increase for all full-time employees who were employed by the County as of 8/31/2023.

1.00% increase for employees hired in September or October 2023. No increase will be given to new hires in November or December 2023.

All in favor.

**Motion** by Commissioner Hann and seconded by Commissioner Wible that the on-call rate for the Services for Children department remain at the same rate of \$407.73 per week for 2024.

All in favor.

**Motion** by Treasurer Mellott-Keefer and seconded by Commissioner Hann that non-union employees in the Courts, Probation, and Domestic Relations Offices receive the following pay increase for 2024:

\$ .50 cent per hour increase for all full-time employees who were employed by the County as of 8/31/2023.

2.50% increase for Court staff.

1.00% increase for employees hired in September or October 2023. No increase will be given to new hires in November or December 2023.

All in favor.

**Motion** Treasurer Mellott-Keefer and seconded by Commissioner Hann that the on-call rate for the Probation department be set as follows for 2024, per the union contract: \$62.00/weekday; \$76.00/weekends. All in favor.

**Motion** by Treasurer Mellott-Keefer and seconded by Commissioner Bunch to adjourn the Salary Board meeting at 9:49 a.m. All in favor.

**Motion** by President Judge Meyers and seconded by Treasurer Mellott-Keefer to reconvene at 12:55 p.m. to revise the court supervised positions. All in favor.

**Motion** by President Judge Meyers and seconded by Commissioner Hann that non-union employees in the Courts, Probation, and Domestic Relations Offices receive the following pay increase for 2024:

\$ .50 cent per hour increase for all full-time employees who were employed by the County as of 8/31/2023.

2.50% increase for Court staff.

1.00% increase for employees hired in September or October 2023. No increase will be given to new hires in November or December 2023.
