Commissioners proposed to increase Park's wages from \$15.02 to \$16.82 for the position of Enforcement Officer II. Commissioners proposed to increase wages for Jennifer Burdge from \$20.57 to \$21.07 for the position of Hearing Officer II. No action was taken.




**Motion by Commissioner Bunch, Seconded by Commissioner Wible to adjourn at 11:15 a.m. All in favor.**


