**Motion** by Commissioner Bunch to call Salary Board to order at 9:00 a.m. All in favor.

**Motion** by President Judge Meyers, Seconded by Commissioner Bunch to approve the payment schedule for 2026 as presented by HR Administrator Mary Huston. All in favor.

**Motion** by Commissioner Hann and seconded by Judge Meyers that non-union employees in the Courts, Probation, and Domestic Relations Offices receive the following pay increase for 2026:

- \$1.00 per hour increase for Department Head.
- \$.50 cent per hour increase for employees who were employed by the County as of 8/31/2025.
- 2.50% increase for Court staff.
- 1.00% increase for employees hired in September or October 2025. No increase will be given to new hires in November or December 2025.

All in favor.

**Motion** by Commissioner Wible and seconded by Interim County Treasurer Amy Bishop that all employees in an office without an elected official as the department head receive the following pay increase for 2026:

- \$1.00 per hour increase for Department Head

- \$.50 cent per hour increase for all non-union employees who were employed by the County as of 8/31/2025.
- 2.50% increase for Court Crier, Tipstaff and Tax Claim.
- 1.00% increase for employees hired in September or October 2025. No increase will be given to new hires in November or December 2025.

All in favor.

- Employee Brad Seville, Building and Maintenance Director, moved to Pay Grade M3 which includes a \$3.59 per hour increase.

**Motion** by Commissioner Bunch and seconded by Commissioner Hann that employees in the Commissioner's Office, Business Office; Voter Registration/Elections Office receive the following pay increase for 2026:

- \$1.00 per hour increase for Department Head.
- \$.50 cent per hour increase for all employees who were employed by the County as of 8/31/2025.
- 1.00% increase for employees hired in September or October 2025. No increase will be given to new hires in November or December 2025.

All in favor.

**Motion** by Commissioner Hann and seconded by Commissioner Bunch that employees in the Treasurer's Office receive the following pay increase for 2026:

- Tax Claim duty is paid as a stipend of \$8,255.88.
- \$.50 cent per hour increase for all employees who were employed by the County as of 8/31/2025.
- 1.00% increase for employees hired in September or October 2025. No increase will be given to new hires in November or December 2025.

All in favor.

**Motion** by Commissioner Wible and seconded by Commissioner Hann that employees in the District Attorney's Office receive the following pay increase for 2026:

- \$.50 cent per hour increase for all employees who were employed by the County as of 8/31/2025.
- 1.00% increase for employees hired in September or October 2025. No increase will be given to new hires in November or December 2025.
- District Attorney is to be paid \$1000 less than a Judge in the Court of Common Pleas.

All in favor.

**Motion** by Commissioner Bunch and seconded by Commissioner Wible that employees in the Prothonotary's Office receive the following pay increase for 2026:

- Clerk of Courts duty is paid as a stipend of \$8,255.88.
- Jury Coordinator duty is paid at an hourly rate of \$23.93 with hours to be submitted monthly to HR Administrator with who worked them (if no hours worked, needs submitted as zero).
- \$.50 cent per hour increase for all employees who were employed by the County as of 8/31/2025.
- 1.00% increase for employees hired in September or October 2025. No increase will be given to new hires in November or December 2025.

All in favor.

**Motion** by Commissioner Hann and seconded by Interim County Treasurer Amy Bishop that the employees in the Coroner's Office receive the following pay increase for 2026:

- \$.50 cent per hour increase for all employees who were employed by the County as of 8/31/2025.
- 1.00% increase for employees hired in September or October 2025. No increase will be given to new hires in November or December 2025.

All in favor.

**Motion** by Wible and seconded by Commissioner Bunch that employees in the Sheriff's Office receive the following pay increase for 2026:

- \$.50 cent per hour increase for all employees who were employed by the County as of 8/31/2025.
- 1.00% increase for employees hired in September or October 2025. No increase will be given to new hires in November or December 2025.

All in favor.

**Motion** by Commissioner Interim County Treasurer Amy Bishop and seconded by Commissioner Hann that the on-call rate for the Services for Children Department remain at the same rate of \$407.73 per week for 2026. All in favor.

**Motion** Commissioner President Judge Meyers and seconded by Commissioner Bunch that the on-call rate for the Probation Department be set as follows for 2026, per the union contract: \$66.00/weekday; \$80.00/weekends. All in favor.

**Motion** by Commissioner Hann and seconded by Commissioner Bunch that the 2026 Retirement Board Officers are as follows: Commissioner Bunch serve as Chairman, Commissioner Wible to serve as Vice-Chairman, Commissioner Hann to serve as Member, County Interim Treasurer Amy Bishop to serve as Treasurer, Chief Clerk Stacey Shives to serve as Secretary. All in favor.


Commissioner Hann noted that Union employee rates will change per the CBA (Collective Bargaining Agreement).
